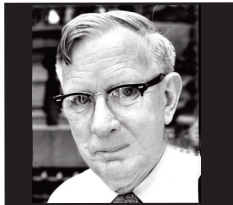


Chapter 46

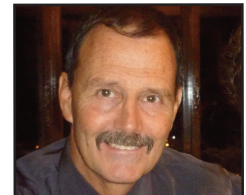
We are also grateful for the godly leadership within our mission on the International level, which supports and strengthens each national and local ministry. Every four years, an international president is elected from among our evangelists. He must be a godly man and seasoned evangelist with at least 10 years of full-time OAC ministry. The purpose of our international president is to fulfill many duties. Some of these include giving leadership oversight to the work, encouraging, guiding, and giving godly counsel, maintaining regular communication with all our staff, publishing written communication to inform both staff and non-staff how God is at work among us around the world, and physically visiting each branch periodically to encourage, minister in the open air, and intervene as a mediator in international and national disputes when necessary. We also have an office of the vice president and an international administrator, if desired, who assist in managing a wide range of tasks.



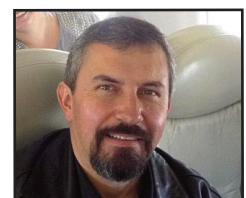

To date, God has given us seven international presidents from diverse backgrounds and locations. We find it encouraging to reflect on how God prepared, gifted, and equipped each of our previous and current presidents for the ministry to which He called them. Our

leadership needs have been met over the years through the unique abilities of these men. We are grateful for the sacrifice in time, effort, and finance each expended to serve us.

A statement of faith, a statement of purpose, a written policy, fellowship, and trust unite all OACI member countries. The work around the world is divided into "zones," geographical areas where two or more OAC national branches minister. As of this writing, our OAC zones include Southeast Asia/Pacific, North America/Caribbean, Latin America, Europe, and Africa. A zone council is composed of national directors or their delegates within the zone, and one of them is elected as the zone's chairman every two years.

Today, our worldwide staff and leadership attempt to gather about every four years for an international conference. This time is open to all staff, board members, and guests and is dedicated to encouragement, prayer, planning, reporting, and ministry in the host country. We desire to hold these conferences in different locations each time to be a help and encouragement to the host country. It's a great blessing to be in one another's company and share face-to-face how God is at work in our spheres of influence.

Our first international conference was held in February 1966 in Australia. Since then, host countries have included the following:

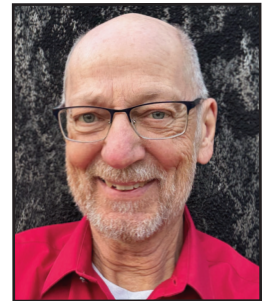
